

- a) Complete Acceptance of Nomination Form (Schedule C);
- b) A deposit of \$100.00 for the position of Hegus and \$50.00 for the position of Legislator made payable to the Tla'amin Nation. This may be provided directly to the Nation with a receipt provided to the Electoral Officer;
- c) Complete Certificate of Qualification (Schedule D),
- d) Evidence (a receipt) that they have submitted a request for Criminal Records Check. Once the criminal record received, please forward to the Electoral Officer; and;
- e) A complete Candidate Code of Fair Campaign Practices form (Schedule A);

AND TAKE NOTICE: that an All Candidates Meeting has been scheduled for 6pm-8pm on September 3rd that will take place at the Salish Centre at Tla'amin Nation.
